Tuesday, December 20, 2022

- 1.Call to Order at 5:05 pm.
- 2. Previous Meeting Minutes.
 - a. A motion was made by Kevin to approve the September 27, 2022, minutes. The motion was second by Kim. Passed unanimously.
- 3. Fundraising and Budget
 - a. No action taken.
- 4. Possible Broadband Partners
 - a. Bill Niemuth, Vilas County Economic Development (VCEDC), stated that VCEDC began working with Charter in August, 2022. VCEDC expected approximately 40 million in available grants, but currently only 14.1 million is available. No cost or contributions from Charter have been received yet. Charter acquired Lakeland Communication, and can therefore use their easements. It is believed that there are approximately 256 households in Plum Lake that are not covered through RDOF (Rural Digital Opportunity Fund), of those, approximately 100 of those are in the Lakeland Communication easement area. The Lakeland Communication area is Hwy 155 to the Southside of Savner and then West on County N. The largest gap in uncovered homes is in the Northwest side along Hwy 70 West and the East Central island. Niemuth stated that he believes Charter is extremely busy due to their RDOF responsibilities, and there are supply issues with fiber optic supplies. LTD was a contractor that received many of the RDOF bids, but they were not approved by the FCC, so Charter will likely attempt to fill those gaps. Charter may not find the value in completing the grant for the remaining 156 homes not covered in Plum Lake. Other possible partners include Bright Speed, Frontier, which is just out of bankruptcy and just won a few large jobs in Marathon and Lincoln counties, and ChoiceTel, who did not express interest when previously approached. Niemuth stated that Plum Lake is in the best position of other towns in Vilas County due to the RDOF coverage. Charter should make a decision as to whether they are interested in partnering with Plum Lake by January 15, 2023. Once Charter advises of a cost, a Special Town Board Meeting would need to be scheduled and a Class II notice would need to be posted 15-20 days prior to the meeting. Niemuth will check with Frontier and Bright Speed in the event that Charter is not interested.
- 5. Available Grants
 - a. The current grant cycle deadline is February 27, 2023. Can re-apply for another grant, if available, if denied for this round of grants.
