Open Meeting Verification: The meeting was duly called by Chair Postuchow at 5:30pm with the notice posted at the Town Hall in Sayner, the US Sayner Post Office, and notice was given to the *Vilas County News-Review*, *The Lakeland Times*, WRJO, WERL, as well as posted on the Town of Plum Lake website.

Motion made by Chair Postuchow to approve the agenda with the discussion and action on the agreements with One Billing Solution, LLC being moved to first on the agenda. **Seconded by** Supervisor Rasmussen. **Vote: Unanimous/Carried**

Town Road /Address Signs Update: Treasurer Klager reported that 300 new address signs have been ordered which is 33% of the total signs needed to be ordered. Once the first 300 signs are received, the next batch of 300 will be ordered.

Asbestos Remediation & Abatement for Town Hall

Ida Nemec asked if the Milky Way Coffee Vendor could run an extension cord to their vendor trailer during the Colorama Bake and Craft Sale. Solution will be worked out with this vendor to allow for proper electrical use. Sheehan Donahue raised concern on behalf of Ann Willer about fungus growing in the Sayner Cemetery.
